





By seizing the opportunity of procurement reform in the fields of military equipment, materials, services and engineering, it has become one of the first civil units to provide procurement consulting and bidding agency services for the military.

By now, Sinochem Commerce has provided professional bidding agency services for more than 150 organizations including government organs like the Equipment Development Department of People's Republic of China Central Military Commission, the Joint Staff Department of the Central Military Commission, the Equipment and Logistics Department of PLA Air Force, the Equipment Department of the PLA Rocket Force, Equipment, the Staff and Logistics Department of the PLA Strategic Support Force, the Equipment and Staff Department of the PLA Navy, the Equipment and Logistics Department of the PLA Armed Police, and the Equipment and Logistics Department of the PLA Land Force as well as the grass root troops, bases, educational institutions and research institutes of different forces. 轨道交通 **RAIL TRANSIT**

船舶工业 SHIPBUILDING INDUSTRY




